## Resolution Proceeding No. 158


A meeting of Governing Body is convened in the chamber of Principal with President G.B. and ADM on chair for discussion on various problems of college specially, Appointment of Guest Lecturers on Dt. 31.07.2020 at 10 A.M.

The Principal apprised the President about the on-line classes started in our college from 13.06.2020 as per letter No. 21891/HE, Dt.. 02.07.2020 of Commissioner –cum- Secretary, Deptt. of Higher Education, which delighted all, But some of the classes are dropped due to lack of teaching faculties in the Deptt. of English, History, Physics, Chemistry, Zoology and Commerce (+2). As the faculties in the department of History, Zoology, Chemistry, English, Odia retired due to superannuation, their post are lying vacant since two/ three years. Last year some guest faculties in the department of Commerce, Physics, Chemistry, Zoology, Odia are appointed as Guest Lecturers which managed the academic atmosphere of college to a large extent. Further the only Demonstrator in the Deptt. Of Physics has, retired in last September, 2019 so one Demonstrator in Physics is urgently required to be appointed.

As the academic year start from 1<sup>st</sup> June and online classes are being started, appointment of Guest Lecturer is inevitable.

The normal procedure of appointment could not be followed as Covid-19 pandemics is spreading its area of infection everywhere. The Central Government and State Government have imposed restriction on all activities of offices and public affairs in general. Under such circumstances, the Principal –cum- Secretary discussed the matter of appointment of Guest Lecturer with President.

The Principal expressed his views on the sincerity & diligence of Guest Lecturers appointed last year & expressed his satisfaction on their academic activities. The G.B come to the conclusion that all the Guest Lecturers appointment last year in the department of Odia, Physics, Zoology and Commerce, Chemistry would be appointed on a temporary basis for six months which will be extended for
