02. Acceptance of the appointment of Sri Prasanta Kumar Mohapatra, Reader in Zoology as the Principal in Charge by the Director.
03. Unauthorized drawal and non-performance of duty of Sri Dambarudhar Bhoi, Ex-Principal and stagnation of his annual increment.
04. Career promotion proposal of the state scale employees of the college.
05. Approval of Local Fund Audit report during the period from 01.04.2015 to 30.06.2017.
06. Any other matters as per the permission of the chair.

Proceeding of the last meeting has been read and confirmed.

Proceeding No. 02

Sri Prasanta Kumar Mohapatra, Reader in Zoology was appointed by the President Governing Body as the Principal in Charge with effect from 01.01.2019 of the college and suggested to the Director, Higher Education, Odisha to accord the approval and delegation of financial power. The Director Higher Education, Odisha has approved the appointment and allowed to Sri P.K. Mohapatra to exercise financial power, since 01.01.2019.

Proceeding No. 03

President Governing Body is the competent authority to sanction leave annual increment and in the matter of recruitments appointment of the Non-Govt. Aided college employee under the rules. Sri Dambarudhar Bhoi whose earlier increment was sanctioned during July 2017 by the President Governing Body has recorded in the personal file. During July 2018 Sri Dambarudhar Bhoi, Ex-Principal in Charge has self sanctioned his increment and drawn in admissible amount. The President Governing Body verified and found that Sri Dambarudhar Bhoi had unauthorizedly sanctioned his own increment and drawn during the month of July and August 2018 which was cancelled and reported to the Director-Higher Education under the intimation to the Sub-Collector, Boudh and Secretary-Dept. of Higher Education, Odisha, Bhubaneswar. His performance were unsatisfactory and activities are objectionable as reported to the Director Higher Education, Odisha & Government by the President Governing Body. Hence his annual increment is stagnant & his basic salary as on 01.07.2017.

Proceeding No. 04


The report submitted by the Screening Committee about the eligibility of the state scale employees for Modified Assured Career Progress is approved.


- (a) The period of the Principal in Charge regarding enhancement of salary is hereby approved. The Principal is authorized to draw and make payment.
